In producing herewith one arrested female accused namely Sabitri Chowhan ( 42 yrs) W/O late Paresh Chowhan of Vill- Ujal, PO+PS- Hilli, Dist.- Dakshin Dinajpur who arrested for contravening the norms of NDPS Act 1985 and I also would like to produce before your kind self the following seized items as follows:-

- One Packet suspect to be Ganja Containing 2.300 Kg of suspect to be Ganja i) wrapped with red colour of plastic sheet, marked as Exhibit 'A' out of which 100 gram of said to be Ganga taken from the packet as sample and marked as Exhibit "A-1"
- One Packet suspect to be Ganja Containing 5.300 Kg of suspect to be Ganja ii) wrapped with red colour of plastic sheet, marked as Exhibit 'B"' out of which 100 gram of said to be Ganga taken from the packet as sample and marked as Exhibit "B-1"
- One Maroon colour bag marked as Exhibit "C". iii)

The fact of the case in brief that on 16.03.21 at 14.35 hrs I received reliable specific source information that one lady is standing at Murder More under NJP PS with one bag in her possession containing Ganja and waiting for a vehicle. Accordingly, I diarized the information in General diary of NJP PS vide NJP PS GDE No 822 Dtd. 16.03.21 and informed the matter to the Officer in-Charge, NJP PS. As per his direction, I accompanying with L/C 328 Punam Rai, L/C 326 Sita Bhutia, ASI Khagen Barman, VP/13 Jamirul Islam and VP/08 Laxman Roy, all of NJP PS left for Murder More under NJP PS to verify the veracity of information vide New Jalpaiguri P.S M .C.C No 605 dtd. 16.03.21. At the time of departure I took with me the necessary articles like white paper, digital weighing machine ,Arrest memo, sealing wax, seal, etc and on the way to the spot I called two independent witnesses namely (i) Soumya Bikash @ Bubai Ghosh S/O late Jyoti Prakash @ Mantu Ghosh of Purba Dhantala, PS- NJP, Dist.- Jalpaiguri and (ii) Sukamal Sengupta S/O late Subir Sengupta of Shaktigarh Road No-3, PS- NJP, Dist.- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany with us in whole process during search and seizure. At about 15:05 hrs we arrived at Murder More under PS NJP and as identified by the source we found that one lady is standing at Murder More with 01 (one ) Maroon colour bag with handle in her right hand and waiting for a vehicle. After disclosing our identity as police personnel of NJP PS, I along with L/C 328 Punam Rai, L/C 326 Sita Bhutia, ASI Khagen Barman, ASI Rash Bihari Saha, VP/13 Jamirul Islam and VP/08 Laxman Roy detained the above noted lady suspect along with 01 (one ) Maroon colour bag with handle in her right hand with strong reason to believe that she is illegally possessing Ganja in the bag in her right hand. Then I told her that as per reasonable information she is carrying contraband Ganja inside the bag in her possession. I told her that we will be conducting search of her and the bag in her possession.
