In producing herewith one arrested accused person namely Subhash Poddar ( 59 yrs ), S/O Late Sudhir Poddar of New Palpara Netaji Sarani w/no.38 PS Bhaktinager Dist. Jalpaiguri in custody and the following articles under seizure from the possession of the above noted accused person ----

- (1) 04 (Four) boxes of "SPASMO-PROXYVON R PLUS" Dicyclomine Hydrochloride Tramadol, Hydrochloride & Acetaminophen Capsules each box containing 70 small boxes, each small box containing 18 strip (Total 4 x 70 x 18 strip = 5040 strip, each strip containing 8 (eight) Capsules), Manufactured by Akums Drugs & Pharmaceuticals Ltd. Marketed by WOKCKHARDT LTD, M.L. 10/UA / 2004, B. NO- WAA0090, MFD-09/2020, EXP 08/2020 marked as exhibit "A-1". One strip of capsule containing eight capsules taken from exhibit "A-1" as sample marked as exhibit "S-1".
- (2) 96 (Ninety Six) boxes of "Nitrosun-10" Nitrazepam Tablets, each box containing 10 (ten) strip, each strip containing 10 tablets. (Total 96 x 10 = 960 strips, Manufactured by Sun Pharmaceuticals, IND LTD, B. NO- DFB 0244A, MFD -12/ 2020, EXP Date 07/2023 marked as exhibit "B-2". One strip of capsule containing 10 (Ten) capsules taken from exhibit "B-2" as sample marked as exhibit "S-2".
- (3) 98 (Ninety Eight) boxes of "CEFEX" Chlorpheniramine Maleate & Codeine Phosphate Syrup, Cough Syrup, each box containing 144 bottles, each bottle containing 100 ML (Total 98 x 144 = 14112 Bottles, Manufactured by THREE B HEALTHCARE LTD, Marketed by SHIZAIN DRUGS AND PHARMACEUTICALS PVT. LTD, B.NO-TBH0230 MFD-02/2021, EXP DT.01/2023 marked as exhibit "C-3". one bottle taken from exhibit "C-3" as sample marked as exhibit "S-3".

I S. I. Pradip Kr Singha of Ashighar OP P. S. Bhaktinager do hereby lodge this complaint against the above noted accused persons and two others namely Sanjit Ghosh S/O Badal Ghosh of Near Alok Sangha Club Sukanta Nager, Rented House Ranjan Sarkar PS Bhaktinager Dist Jalpaiguri and Sanku Raha S/O Late Debi Prasad Raha of Meghla Roy Road Jiban Mohari Gadda Near Bhaban PS Bhaktinager Dist Jalpaiguri to the effect that today on 16.03.2021 at 14.10 hrs. received a secret source information from my source that one person namely Subhash Poddar of new Palpara, Netaji Sarani stored a huge quantity of restricted Narcotics drugs inside his house at New Palpara, Netaji Sarani without any valid papers with a view to sell the drug to local drug peddlers at Silliguri and surroundings area. Accordingly, I diarised the matter vide Ashighar OP G.D.E. No. 419 dated -16.03.2021 and informed the matter to O/C, Ashighar OP and as per his kind instruction myself along with A.S.I. Ujjal Mandal and C/1013 Sanjay Singh, CV/909 Nitya Nanda Choudhury all are of Ashighar OP left for New Palpara Netaji Sarani, at 14.15 hrs. to verify the veracity of the information vide Ashighar OP G. D. E. No. - 420 Dated - 16.03.2021. On way to New Palpara, Netaji Sarani, I called two independent witnesses namely [1] Dipankar Saha (31) S/O Shankar Saha of Ghugumali Niranjan Nager PS Bhaktinager Dist. Jalpaiguri and [2] Sujit Roy (28) S/O Sanjay Roy of Naresh More PO Ghugumali PS Bhaktinager Dist Jalpaiguri and informed them about the information in hand and requested them to accompany us to witness for search and seizure if necessary. At about 14.45 hrs. myself along with my accompanying party arrived at New Palpara, Netaji Sarani and as indicated by my source. At 14.55 hrs. myself along with my accompanying party surrounded the house of above noted accused person. On being asked he disclosed his identify as noted above. On being further asked he stated that he has stored huge quantity of restricted Narcotics drug at his store room. After disclosing our identity I asked him whether he has any objection if search is conducted in his store room in presence of any Executive Magistrate or Gazetted officer and he agreed to be searched in presence of any Gazetted Officer. I served

in a notice in accordance with the provisions of law in this regard. Then at 15.05 hrs. of 16.03.2021 I apprised Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC and requested him to remain present at the spot as Gazetted Officer. At 15.30 hrs. Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC arrived at the spot. I disclosed the identity of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC to the accused person as Gazetted Officer. Under supervision of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC and the above noted witnesses the store room of above noted accused person. He further confessed in presence of Gazetted Officer and other witnesses that he along with Sanjit Ghosh S/O Badal Ghosh of Near Alok Sangha Club Sukanta Nager, Rented House Ranjan Sarkar PS Bhaktinager Dist Jalpaiguri and Sanku Raha S/O Late Debi Prasad Raha of Meghla Roy Road, Jiban Mohari Gadda Near Bhaban PS Bhaktinager Dist Jalpaiguri procured the restricted Narcotics drug from Barrapore, Kolkata clandestinely for the purpose of selling it to the drug peddlers of Siliguri and surroundings area with a view to earn huge money quickly. On interrogation he disclosed that he had been dealing in such business for last few years importing it from Barrackpore and selling the same to the drug peddlers of Siliguri and surroundings area. On being asked he failed to produce any documents or license in support of his possession of such restricted Narcotics drug. Then as per direction of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC I counted and found (1) 04 (Four) boxes of "SPASMO-PROXYVON R PLUS" Dicyclomine Hydrochloride containing 18 strip (Total 4 x 70 x 18 strip = 5040 strip, each strip containing 8 (eight) Capsules), manufactured by Akums Drugs & Pharmaceuticals Ltd. Marketed by WOCKKHARDT LTD, M.L. 10/UA/2004, B. NO- WAA0090, MFD-09/2020, EXP 08/2020 marked as exhibit "A-1". One strip of capsule containing eight capsules taken from exhibit "A-1" as sample marked as exhibit "S-1". (2) 96 (Ninety Six) boxes of "Nitrosun-10" Nitrazepam Tablets, each box containing 10 (ten) strip, each strip containing 10 tablets (Total 96x10 = 960 strips), manufactured by Sun Pharmaceuticals, IND LTD, B. NO- DFB 0244A, MFD-12/2020, EXP Date 07/2023 marked as exhibit "B-2". One strip of capsule containing 10 capsules taken from exhibit "B-2" as sample marked as exhibit "S-2". (3) 98 (Ninety Eight) boxes of "CEFEX" Chlorpheniramine Maleate & Codeine Phosphate Syrup, each box containing 144 bottles, each bottle containing 100 ML (Total 96 x 144 = 14112 Bottles), manufactured by THREE B HEALTHCARE LTD, Marketed by SHIZAIN DRUGS AND PHARMACEUTICALS PVT, LTD, B. NO-TBH0230 MFD-02/2021, EXP DT.01/2023 marked as exhibit "C-3". One bottle taken from exhibit "C-3" as sample marked as exhibit "S-3" and seized all the above noted recovered articles as Alamut under proper seizure list under the supervision Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC duly signed by the local witnesses and the accused persons. The seizure was made in between 16.30 hrs and 17.05 hrs. Then, I arrested the above noted accused person after observing all formalities of arrest as well as after disclosing the cause of arrest and issued necessary memo of arrest duly signed by the accused persons and witnesses. The copy of seizure list and memo of arrest have been supplied to the above noted accused persons under receipt. Thus, the accused persons violated the terms and conditions of N. D. P. S Act. for possessing such restricted Narcotics drug without any legal authority.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely Subhash Poddar (59 yrs), S/O Late Sudhir Poddar of New Palpara Netaji Sarani w/no.38 PS Bhaktinager Dist. Jalpaiguri (2) Sanjit Ghosh S/O Badal Ghosh of Near Alok Sangha Club Sukanta Nager, Rented House Ranjan Sarkar PS Bhaktinager Dist Jalpaiguri and (3) Sanku Raha S/O Late Debi Prasad Raha of Meghla Roy Road Jiban Mohari Gadda Near Bhaban PS Bhaktinager Dist Jalpaiguri and arrange for its investigation.
