With due respect, I SMT RITWIKHA CHATTERJEE (ROY), W/O Sri
Shekhar Chatterjee, D/O Sri Pradip Kumar Roy, Residing at Madhya
Shantinagar, P.O. Dabgram, P.S. Bhaktinagar now (Ashighar), Dist-
Jalpaiguri, would like to lodge this written complaint to the following
effect:-

1. That SRI SHEKHAR CHATTERJEE, S/O Sri Shankar Chatterjee,
residing at Madhya Shantinagar, P.O. Dabgram, P.S. Bhaktinagar,
Dist- Jalpaiguri is my legally married husband and our marriage was
solemnized on 11.10.2021 according to Hindu Rites and Customs at
Madhya Shantinagar, P.O. Dabgram, P.S. Bhaktinagar, Dist-
Jalpaiguri.
2. That after the said marriage I along with my husband started to living
as husband and wife in my matrimonial house address mentioned
above. That after few days of our marriage I came to know that my
husband is a habitual drunker and he used to come into the home in
drunken condition and started to torture upon me for demand of Rs.
1,00,000/- as dowry and also used filthy languages towards me and my
family members.

3. That my husband along with his family members started to torture upon me both physically and mentally and used to demand of Rs. 1,00,000/- cash from my father and when I failed to bring the said amount my husband and in-laws members used to assault me physically and mentally.
4. That due to said law-full wed-lock with my husband, I gave birth one male child on 11.08.2015, whose name is Master Sourajit Chatterjee, presently he is in custody of my husband. That despite the above mental, physical and in human torture I keep my patience and hoping one day everything would be normalized, but the things goes worse day by day. That due to the said torture I compelled to take shelter at my parental house and my husband forcefully detained my child in his custody.
5. That finding no other alternative I have filed an application U/S 13(1)(b) of Hindu marriage act, before the Ld. District Judge, Jalpaiguri and the said application is still pending.
6. That today when I went to my matrimonial house for meet with my son, my husband and my father in-law forcefully restrain me and also beat me mercilessly and due to said physical assault by my husband and father-in-Law namely Shekhar Chatterjee i have receive severe injury on my body (medical report annex herewith).
