Respected Sir,

I, Smt. Bina Gupta, Wife of Deshbandhu Prasad, resident of Vidyasagar Pally, Near TOP-II, Ward No.7 of S.M.C., P.S. Siliguri, Dist. Darjeeling, West Bengal, would like to state you following facts:-

That yesterday i.e. on 16.03.2021 at about 11:30 a.m. my neighbours namely (1) Sri Mahabir Prasad, Son of Ramabtar, (2) Sri Amit Gupta, Son of Mahabir Prasad, (3) Sri Saichun Gupta, Son of Sri Mahabir Prasad, all are of Vidyasagar Pally, Near TOP-II, Ward No.7 of S.M.C., P.S. Siliguri, Dist. Darjeeling, (4) Sri Sheo Kumar and his son & (5) Sri Pankaj Gupta, all are of Minal Pally, Opp. side Sharda Office, P.S. Siliguri, Dist. Darjeeling all of them suddenly entered into our house and started to abuse in filthy languages and starting threatening at the relevant time only I and my old age father-in-law whose age is 95 years was present in the house. The above named miscreants forcefully entered in our house and started ransacked of household articles and in the mean time the said Mahabir Prasad entered into my bed room and took cash Rs.17,000/- (Rupees Seventeen Thousand) from my almirah. Hearing hue and cry the para-people gathered on the spot and saved us from their hands.

Sir, at the time of incident only I and my old aged father in law was present in our house. They above named accused are my neighbours and they know it very well about the location and business of my family members. The above named accused are dangerous and desperate in nature. They openly threatened me that anytime they may murder me and my family members.

Sir, due to fear and confusion I could not lodge F.I.R. in due time which kindly may condoned.

I, therefore, request you to kindly take necessary legal action against the aforesaid culprits for the commission of the aforesaid offence by them upon us.
