Sir,

I, Smt Nikita Chanda, Wife of Sri Sujit Chanda, Residing at New Township, P.O. Sushrutanagar, P.S. Matigara, District- Darjeeling, Pin - 734012, do hereby lodge this complaint against Sri Sujit Chanda, Subodh Chanda, Tumpa Chanda, Madan Sarkar and Mala Sarkar, son of Madan Sarkar to the effect that that I was married to Sri Sujit Chanda, son of Late Subal Chanda on 12.06.2016 who is a CRPF Jawan presently posted in Manipur. Since the inception of marriage I have been victimize of mental and physical cruelty by my husband Sri Sujit Chanda and my in-laws Sri Subodh Chanda, son of Late Subal Chanda and Smt Tumpa Chanda, wife of Sri Subodh Chanda. The aforesaid three persons over the years have physically assaulted me on many occasions but I kept mum for the sake of welfare of my minor daughter aged about two and half years. The said Sujit Chanda has left me and my daughter in a starvation situation since March, 2020. I am presently residing at New Township, P.O. Sushrutanagar, P.S. Matigara, District- Darjeeling alone with my minor daughter and the said Sri Sujit Chanda, Subodh Chanda, Tumpa Chanda, Madan Sarkar and Mala Sarkar, wife of Madan Sarkar since last year is continuously threatening me to abandon my house to them and go to Kolkata.

Today at morning about 11.30am when I along with my minor daughter were coming to home the said Sri Sujit Chanda who has come to Siliguri in his vacation along with Subodh Chanda, Tumpa Chanda, Madan Sarkar and Mala Sarkar, wife of Madan Sarkar all residents of Naukaghat, P.O.-Siliguri Bazar, P.S.- New Jalpaiguri, District- Jalpaiguri stopped my scooter near their house at the main road at Netaji Pally, Noukaghat and the said five persons forcefully pulled me and my minor daughter from the scooter and abused me in a filthy language and pulling my hair the said persons started assaulting me with fists and blows in my body parts and threatened me to leave my house or else they will forcefully throw me out of my house and that they will even kill me if required. Thereafter the said Sujit Chanda, Subodh Chanda and Madan Sarkar physically assaulted me in an outrageous manner and touched my private parts and turn by turn they kicked me in my vagina. Then the said five persons tied my leg and hit me with lathi, wooden sticks in my legs, back, hand, head and other body parts
