I, Anamika Mukherjee, residing at East Vivekananda Pally, want to draw your attention that I and my husband Amit Sinha, residing at Chitta Bhawan, Bankim Chandra Road by lake near Sanghati Market married on 2.12.2009 at Swri, Birelham. After marriage due to my husband's job we shifted to Siliguri. But due to my husband's physical and mental torture and their family members mental torture I left my husband's house on 5th February 2021. My husband came on 18.3.2021 to meet our son Aagnik Sinha at my rented resident. He forced to take our son away with him but I denied him and he started using abusive language in front of our son. I tried to tell him that due to corona and our son's mental trauma it is unsafe for him to go out with him right now. After all these he pushed my son and me intentionally. And left threatening that he will come again to take my son away. He used to torture me both physically

Sir, I request you to look after this matter kindly and please take action against him as we are very much unsafe. We will be very much thankful to you.
