At Around 11.40 hrs on 19.03.2021 morning Power House Customer Care center received information regarding damage of electric lines in Khola Chand Fafri, Near 70 More, P.S Bhaktinagar, Dist- Jalpaiguri. On reaching the site, the maintenance van of Power House Customer Care Center found that one Truck having Vehicle no WB61-2387, had broken 5 span of LTAB (Low Tension All Bundle) cable and caused other damages to the Electric Lines which are the property of WBSEDCL. The total damages caused by the vehicle are approximately around Rs 41381/- (Forty One thousand Three Hundred & Eighty One Rupees). Thus you are requested to kindly initiate an investigation against vehicle no WB61-2387 under Section 139 of The Electricity act 2003 amended on 2007 of India.
