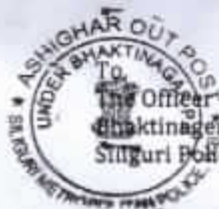

Sir,

In producing here with one accused person namely Keshab Sarkar (19) S/O Rabin Sarkar of Hatiadanga Near Tarapit Kall Mandir, Ashighar PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure:

(1) 16 (Sixteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.100/-

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Keshab Sarkar (19) S/O Rabin Sarkar of Hatiadanga Near Tarapit Kall Mandir, Ashighar PS Bhaktinagar Dist. Jalpaiguri to the effect that, on 20.03.2021 evening as per order of O/C Ashighar OP I along with SI Swapan Ghosh, C/ 134 Ginen Basumata and C/1013 Sanjay Singh, all are of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashighar OP in course of which I received information from my source that one Keshab Sarkar stored a huge numbers of bottles of liquor inside his house at Hatiadanga Near Tarapit Kallmandir, and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Hatiadanga Near Tarapit Kallmandir area to verify the veracity of information. On the way I called two local person namely (1) Ajay Sarkar (30) S/O Sunil Sarkar of Niranjan Nager W/no 36 PS Bhaktinagar dist. Jalpaiguri and (2) Shankar Mandal (30) S/O Sunil Mandal of Ashighar Coloney PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Hatiadanga Near Tarapit Kallmandir area as indicated by my source I held raid at the house of Keshab Sarkar at Hatiadanga Near Tarapit Kallmandir, But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 20.45 hrs and 21.05 hrs on 20.03.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons namely Keshab Sarkar (19) S/O Rabin Sarkar of Hatiadanga near Tarapit Kall Mandir, Ashighar PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
