I, Debashish Das, 9/10 late Sri Kartick Chandra Das,

state as follows:

That on 20.03.2021, at about 03:25 hours, a theft of
a lot of expensive articles, silver ornaments (amounting
to more than ₹ 25,000 approx) and cash to the tune of
₹ 10000/- was committed in our house.

That on 20.03.2021, when my wife and I woke up,
we realised that the locks of a few almirahs were
broken and the lock of the door was broken too.
