In producing herewith one arrested accused person namely Pramit Mandai (22) 5/0 Late Netal Mandal of South Colony near Kall Mandir, 8, PS. NJP Dist-Jalpaiguri along with Sir. seized article vize-

1. One improvised fron made fire arms in working condition measuring approx 10. 08 inches from barrel to fron butt having striking pin, hammer and trigger, wisself exclusively from the possession of the above noted accused derson.

I, St Uday Chakraborty of Siliguri Police Station, Siliguri police Commissionarate do hereby lodge this complaint that on 22,03.21 at around 18.35 hrs, received a secret source information that one person was moving suspiciously at Tikiapara mear Vegetuble market under Siliguri PS with an ulterior motive and is in possession of firearms. Dairsed the mater vide Siliguri PS 60 entry no.1335 dated 22.03.21. Accordingly I informed the matter to the I/C Sibputi 95 and as per your kind instruction Lalong with ASI Siben Sarkar, ASI Subir Sen, CV/145 Bijay Das CV/922 Ramaruth Barman, all of Siliguri P.S. rushed to the place at Tixiapara near Vesetable market, and on way picked up two disinterested witnesses namely (i) Abhijit Roy (19) 5/O Khitush Roy of Tippapara, Matangini Colony II, Ward No. 28, PS. Shiguri, Dist. Darjeeling und 2) Rabit Karmokur (18) 5/O MotSal Karmokur of do, duly informing them about the information in band. At 18,55 hrs I along with force reached at Tikiapara near Vegetable market and after long time, as per identification by the source, myself along with force managed to apprehend the person. On being asked, the apprehended person disclosed his identity as noted above.

Accordingly, as per information and following all necessary procedures of search of the police person in presence of witnesses, search of the apprehended person Pramit Mandai 5/0 Late Netal Mandal of Southe Colony near Kall Mandir, 8, P5- NJP Dist- Jalpaiguri was made. On search One Improvised fron made fire arms in working condition measuring approx 10, 08 inches from barriel to Iron butt having striking pin, hammer and trigger, which was kept concealed under his Pant on the right side of his below the waist. On being asked about the possession of the firearm, the apprehended Pramit Mandai made incoherent statements. On being asked he tailed to produce any valid documents in respect of said Fire Arm. On further interrogation he stated that he had procured the said Fire Arm illegally with intend to sale under Siliguri area for his wrongful gain.

As there is every reason to believe that the firearm recovered has been procured dishonestry by the apprehended Pramit Mandal for his ulterior motive, seized the firearm duly taking its measurements and details in presence of the witnesses duly signed by them and acknowledge by the apprehended Prumit Mandal and arrested him following all formalities. The seizure and label has done between 20.15 hrs to 20.55 hrs. Then I arrested him u/s 41 of CEPLL

Under the above circumstances, I pray that a specific case under Arms Act may kindly be started against the arrested person namely Pramit Mandal (22) S/O Late Netal Mandal of Southa Colony near Kali Mandar, 8, PS- NJP Dist. Jalpaiguri and arrange for its investigation.
