Sir,


I am producing herewith three (03) arrested accused persons namely (1) Bishal Ghosh (21) S/O Lt Dilip Ghosh of Ratanlal Busty, P.S-Pradhannagar, Dist. Darjeeling, (2) Arjun Prasad (19) S/O Shib Kr Prasad, of Surya Sen Colony, Mallaguri, P.S-Pradhannagar, Dist. Darjeeling & (3) Md Sagar (21) S/O Md Mobarak of Paribhannagar, Truck Stand, Jhupri Busty, P.S-Matigara, Dist. Darjeeling arrested along with following seized articles under proper seizure list viz.

- (i) One Iron made Sabol measuring 60 cm (approx) seized from the possession of Bishal Ghosh which was kept concealed on his back side,
- (ii) One Iron made Khukri measuring 28 cm (approx) in length including wooden butt measuring 11cm (approx) seized from the possession of Bishal Ghosh which was kept concealed on his back side
- (iii) One Steel made knife measuring 16cm (approx) in length including Steel made butt measuring 10 cm (approx) seized from the possession of Arjun Prasad which was kept concealed on his back side
- (iv) One iron made hammer measuring 9 cm (approx) in length including iron made butt measuring 42 cm (approx) seized from the possession of Md Sagar which was kept concealed on his back side

I, ASI- Debasish Das of Pradhannagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (1) Bishal Ghosh (21) S/O Lt Dilip Ghosh of Ratanlal Busty, P.S-Pradhannagar, Dist. Darjeeling, (2) Arjun Prasad (19) S/O Shib Kr Prasad, of Surya Sen Colony, Mallaguri, P.S-Pradhannagar, Dist. Darjeeling & (3) Md Sagar (21) S/O Md Mobarak of Paribhannagar, Truck Stand, Jhupri Busty, P.S-Matigara, Dist. Darjeeling and others to the effect that on 20.03.2021 at 00:10 hrs I received a sources information that 8/9 youths have assembled at Millan more, under PDN PS with deadly weapons and making preparation for committing dacoity at the area. Accordingly, I shared the information with you and as per your kind direction diarized the fact vide PDN P.S GDE No. 1306 dated 20.03.21 and consequently, I along with force CV/131 Ranjan Sharma, CV/128 Ajay Sahani, CV/223 Swapan Chetty, CV/646 Baban Das, CV/645 Pamkaj Gupta left P.S to verify the veracity of information. At 00:40 hrs reaching near Millan more and kept our vehicle there and proceeded towards Milon more, on foot and, being indicated by the source found from a considerable distance that a gang of 8/9 persons were assembled in dark place at Milon more and they were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of police party, they scattered in multi direction and started fleeing away but we managed to apprehend three persons along with the above noted articles from their exclusive and conscious possession as mentioned above, whereas the rest accused persons managed to flee away from the spot.

On interrogation the apprehended accused person disclosed their identity as above and admitted that they and along with Suraj Chettri and others had assembled there to commit dacoity in that area.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.15 hrs to 01.45 hrs. Thereafter, I arrested the above noted accused persons under proper memo of arrest duly signed by the accused persons and also supplied the copy of the memo of arrest to them after informing the ground of their arrest.

I accordingly brought the arrested accused persons along with seized article at Pradhannagar Police Station for further enquiry. During the course of interrogation it could be revealed from the arrested accused persons and some others were also with them, but they able to flee away from the spot during the raid.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Bishal Ghosh (21) S/O Lt Dilip Ghosh of Ratanlal Busty, P.S.-Pradhannagar, Dist. Darjeeling, (2) Arjun Prasad (19) S/O Shib Kr Prasad, of Surya Sen Colony, Mallaguri, P.S.-Pradhannagar, Dist. Darjeeling & (3) Md Sagar (21) S/O Md Mobarak of Paribhannagar, Truck Stand, Jhupri Busty, P.S.-Matigara, Dist. Darjeeling, Suraj Chettri and others arrange for its investigation.
