In producing herewith the arrested accused persons, namely, (i) Shiv Kumar (28 Yrs) S/O Ram PratapSahani of Ward No. 06, PO Basahi, PS Cheria Bariarpur, Dist. Begusarai, Bihar - 848202, (ii) M. Nataranjan (57 Yrs) S/O Lt. Muniandi of No. 93/5, Thiruveethiamman Street, Melnaduvankarai, Anna Nagar, Chennai, Tamil Nadu -600040 and present resident of Moreh, Ward No. 3, Tengnoupal, Chandel, Manipur-795131 along with the following seized articles, viz.,

- i) One yellow coloured packet wrapped by a transparent cello-tape containing 50 (fifty) blue coloured small pouches having 200 (Two Hundred) each Yaba Tablets, amounting total 10,000 (Ten Thousand) Yaba Tablets. The each pouches having symbol of Globe (World Map) on it, marked as Exhibit - 'A'
(The tablets contain mixture of methamphetamine and caffeine.)
- ii) Ten Yaba Tablets each in two separate packets, extracted from Exhibit A as sample, marked as Exhibit A1 and Exhibit A2 respectively.
- iii) One yellow coloured packet wrapped by a transparent cello-tape containing 50 (fifty) blue coloured small pouches having 200 (Two Hundred) each Yaba Tablets, amounting total 10,000 (Ten Thousand) Yaba Tablets. The each pouches having symbol of Globe (World Map) on it, marked as Exhibit - 'B'
(The tablets contain mixture of methamphetamine and caffeine.)
- iv) Ten Yaba Tablets each in two separate packets, extracted from Exhibit B as sample, marked as Exhibit B1 and Exhibit B2 respectively.
- v) Four separate packets (transparent packets) containing white colour psychotropic substance (crystal like) seems to be Cocaine weighing 01(one) Kgs each. Weighing 04(four) in total, marked as Exhibit 'C', 'D', 'E' and 'F' respectively.
- vi) 08(eight) separate packets containing 10 (ten) grams each, extracted from Exhibit 'C', 'D', 'E' and 'F' respectively in two separate packets from each of the exhibits mentioned above as sample, marked as Exhibit 'C1' and 'C2', 'D1' and 'D2', 'E1' and 'E2' & 'F1' and 'F2' respectively.
- vii) One Aadhaar Card No. 9834 5821 0481 in the name of Shiv Kumar S/O Ram PratapSahani of Ward No. 06, PO:Basahi, PS CheriaBariarpur, Dist. Begusarai, Bihar -848202

- xiii) One NOKIA Android phone, black and blue in colour, having IMEI No. 353398093240092, 353398097740097, having SIM Card No. 7904570567, found and seized from the possession of accused M. Natarajan.
- xiv) One Micro-max key-pad mobile phone having IMEI No. 911544352395961, 911544352395979, having SIM Card No. 9362502771, found and seized from the possession of accused Shiv Kumar.
- xv) One Realme Android phone having IMEI No. 865314049480279, 865314049480261, having SIM No. 6909673866, 8413803611, found and seized from the possession of accused Shiv Kumar.

The fact of the case is that on 20/03/2021 at about 23.15 hrs., received information from a reliable source that some persons are staying in a hotel at Patel Road area at Pradhan Nagar, Siliguri under Pradhan Nagar PS, Dist: Darjeeling and they are in possession of huge quantity of contraband articles with them. I informed the matter my superiors and as per his direction, a team consisting of myself, along with Assistant Sub Inspector Apurba Ghosh, C/ 60 Pradip Roy and C/ 115 Ajimul Hoque, C 1495 Pritam Pramanik and C/ 111 Ekash Oraon left for Pradhan Nagar PS, Siliguri in a hired Govt. Vehicle WB 94G- 6060, driven by CV Driver 2635 Md. Pappu.

On arrival, I submitted a requisition to I/C Pradhan Nagar PS for Police assistance on 20/03/21 at 23.55 Hrs. This refers to Pradhan Nagar PS GDE No. 1418 Dated 20.03.2021. I along with STF team duly accompanied by SI Haren Kumar Mahanto (RT Night Mobile officer) and force of Pradhan Nagar Police Station left the PS and arrived at Patel Road and met with source at 00:15 hrs. at 21/03/2021. He identified the place and room where the miscreants were staying. We called local persons and asked them to be present during the operation as public witness. Accordingly, I) Muzaffar Alam (19 Yrs) S/O Allauddin of Vill. Dolapara, PO Ashan Busty PS Chopra, Dist. Uttar Dinajpur II) Lutfar Hossain (20 Yrs) S/O Anarul Islam of do, who worked in the lodge where the miscreants were staying, remained as public witness.

We then proceeded to Room No. 206, Sarama Lodge, Patel Road, Pradhan Nagar which the source had identified. On arrival there, in presence of witnesses, I knocked on the door and on answer; I asked the occupants of the room to step outside. The two male persons noted above stepped out of Room No. 206 and I started to examine them on the corridor of the hotel without entering into their room. On questioning, they replied that that they were in common possession of some contraband articles inside the room. Soon-after, I contacted Shri Sudip Bhattacharya, DySP, STF WB HQ at Siliguri and shared him the information and requested him to come to the noted place. Thereafter, I placed guard on the door of the room and detained both the occupants. After some time, Shri Sudip Bhattacharya arrived on the spot. I narrated the whole fact to him and introduced the detained two persons to my superior officer present there. I gave in writing to both of them to search the police team before we could search them. However, they stated that they did not want to search me and my team and stated that they were willing to be searched by me. Thereafter, in the presence of Gazetted Officer, Shri Sudip Bhattacharjee, Deputy Superintendent of Police, STF WB and local witnesses, I started searching the room they were occupants of i.e. Room No. 206 of Sarama Lodge.


During the search of the room, we found the above noted seized articles in the common possession of the accused persons. I then tested the seized tablets with Drug Test Kit and it could be learned that the tablets contain a mixture of methamphetamine and caffeine and the white powder like crystals tested to be Cocaine. I then sent a requisition to I/C Pradhan Nagar PS for supply of Weighing Machine through PS Malkhana through Spl messenger. Then, on arrival of weighing machine through Spl. Messenger, he handed over the machine to SI Haren Kumar Mahanto of Pradhan Nagar PS, present there. I seized the digital weighing Machine styled as 'REALTECH' Made in India from him on 21.03.21 at 01:20 Hrs and weighed the Cocaine and I labeled, packed, sealed and seized the articles in presence of above noted witnesses. Thereafter, I handed over the digital weighing machine in Zimma-nama to SI Haren Kumar Mahanto of Pradhan Nagar PS present with us. The process of search and seizure was done in-between 01:25 hrs and 04:45 hrs on 21.03.2021. Subsequently, I arrested both the accused persons on 21.03.2021 at 04:50 hrs. Thereafter, I examined the local people around and tried to find out more about the accused persons. So, there was delay in leaving the place of occurrence. I along with the arrested persons and Police team left for Pradhan Nagar PS with the seized articles on 21.03.2021 at 07:25 hrs.

On 21.03.2021 at 08:05 hrs., I along with force and arrested accused persons then after arrival at Pradhan Nagar PS, I drafted this complaint on my personal laptop (DELL) and printed it on PS Printer. I thereafter handed over the accused, seized articles and all relevant documents to IC Pradhan Nagar PS with a prayer to start a specific case against the accused persons for the crime that have committed.

It is to inform you that as per the direction of the STF WB higher authority, the case will be taken up for its further investigation by STF WB and SI Avishek Lama of STF WB HQ at Siliguri may please be assigned as IO of the case.
