Sir,

I ASI Ratan Pradhan presently posted at Pradhannagar PS, SPC lodge this written complainant against the owner of The Yatri bar cum Restaurant and manager of The Yatri bar cum Restaurant

In this regard I beg to state that on 21.03.2021 while performing special night patrolling mobile van duty at Junction area along with other officer ASI Ashit Singha and force CV/131 Ranjan Sharma, CV/128 Ajay Sahani, CV/223 Swapan Chettri, CV/646 Baban Das, CV/645 Pamkaj Gupta, vide PDN PS GDE No.1474 dtd.21.03.2021 and at around 22:50 hrs visited the Yatri bar cum Restaurant situated at Junction area under Pradhannagar PS, SPC and found that the singers were singing and dancing on the dice. I informed the fact to you, and as per your direction, I about to ask to produce the licence for the same. But in due time the manager and owner manage to conceal them. ON enquiry it could be learnt that they do not have such license. So the owner and the manager have violated the Rule 239 of West Bengal Excise Foreign Liquor Rules, 1998 of license issued by Collector Darjeeling

The owner and the Manager of The Yatri Bar cum Restaurant were running with the dancing programme inside the bar by singers making an obscene. They are doing it for their wrongful gain violating the terms and conditions of the licence.

Hence, I am requesting before your kind self to start a specific case against the owner and the Manager of The Yatri Bar cum Restaurant under proper section of law.
