I, SI Sajal Roy of Bhaktinagar P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against namely; (1) Abdul Hossain (20) S/O Ahmed Hossain of New Prakash Nagar ,W/no-43 PS- Bhaktinagar Dist-Jalpaiguri (2) Maksedul Hoque (22) S/O Majibur Rahaman of Netaji nagar, Near Masjid, Ward No. 42, PS- Bhaktinagar Dist-Jalpaiguri , and (3) Piku Roy (30) S/O Lt. Sushil Roy of Prakashnagar ,near Shibmandir ,W/no-42 PS-Bhaktinagar Dist- Jalpaiguri under arrest along allowing with following articles; (i) One (01) one knife measuring approx. 14" including handle recovered from the possession of Abdul Hossain (knife was on his hand) (ii) One iron rod measuring approx. 30" pointed at one end (seemed to be implement of house breaking) recovered from the possession of Maksedul Hoque and (iii) One Dao (Sharp Cutting weapon) measuring approx. 18" including its handle recovered from the possession of Piku Roy , which he was holding on his hand.

In this regard, I beg to report that on 23.03.2021 at 00.15 hrs received secret reliable source information that about 10/12 anti socials armed with deadly weapons assembled at Damping Ground, Eastern Bypass area making preparation to commit datoity at Haiderpara area. I informed the source information to IC Bhaktinagar PS and noted the information vide Bhaktinagar PS GDE No. 1436 Dated 23.03.21. As per the direction of IC Bhaktinagar PS, at 00.25 hrs, I along with ASI Biswajit Saha C/762 Majibur Rahaman, CVF/619 Dharmendra Roy, CVF-935 Biplab Roy left for working out the information vide Bhaktinagar PS GDE No. 1437 Dtd. 23.03.21 after briefing officer and force properly and also along with required papers / articles. At around 02.45 hrs we reached near Damping Ground side and kept our vehicle at considerable distance. Then, I along with Officers and force headed towards Damping Ground looking for witnesses, if any on the way and found witnesses namely: (1) Dipak Biswas (35) s/o Lt. Gopal Biswas of Jaleswari ,Saradamore PS -Bhaktinaga, Dist.-Jalpaigurig and requested him to be present during search and seizure if any. By the time we reached Damping Ground, as informed by secret source, in faint light of street lights on the west side corner, we could see a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted three persons could be apprehended and detained. Then, after disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and address as noted above and admitted that they along with 8/9 others assembled at the spot making preparation to commit datoity tonight at Haiderpara area. I accordingly searched them in presence of witnesses and found (i) One (01) one knife measuring approx. 14" including handle recovered from the possession of Abdul Hossain (knife was on his hand) (ii) One iron rod measuring approx. 30" pointed at one end (seemed to be implement of house breaking) recovered from the possession of Maksedul Hoque and (iii) One Dao (Sharp Cutting weapon) measuring approx. 18" including its handle recovered from the possession of Piku Roy, which he was holding on his hand. interrogation, they admitted that they all assembled there at the behest of Abdul Hossain were making preparation for committing Dacoity tonight in Haiderpara area but 8/9 others managed to escape. Accordingly, I seized above noted weapons in presence of above mentioned witness under proper seizure list duly signed by them and arrested them informing them their ground of arrest preparing memo of arrest. The seizure was made in between 02.25 Hrs to 02.55 Hrs of dated 23.03.21.

From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit

dacoity at nearby Haiderpara area.

Further, it to mention here that the arrested accused persons are well known anti

socials and have been indulged in many criminal cases.

Therefore, I pray before you to start a specific case against them and 8/9 others who fled away under proper section of law and to cause its investigation.
