With due respect we, NANDA KISHOR CHOWDHURY s/o Satya Narayan Choudhury and DILIP KUNDU s/o Anil Kundu both are resident of matigara, p.o & p.s – matigara, district : Darjeeling beg to inform you that we both are young educated and for the sake of our livelihood. We have purchased WAGON R being Registration Number: WB779556 and MARUTI WAGON R VXI being Registration Number: WB74AV393 respectively on bank finance.

It is pertinent to mention here that we have purchased our said vehicle solely on the basis of assurance by one RAJAT KUMAR GUHA s/o Ratan banik guha , resident of no.1 dabgram, sarat Chandra bose road , ward – 23 of smc , p.o – Rabindra sarani, district : Darjeeling who used to carry on travelling business under the name and style i.e M/S GLOBAL ENTERPRISE / PARADISE TRAVELS and accordingly said rajat kumar guha took our said vehicle in his procession by executing lease deed in respect our said vehicle for a monthly of 1.Rs.13000/- 2. Rs. 17000/-

It is to be noted here that initially as per terms of said lease deed, RAJAT KUMAR GUHA started to make payment to us.

It is to be noted here that said RAJAT KUMAR GUHA with the help of his men namely NABARUN DEY (gango) s/o bapi dey resident of barabisa , uynder p.s – Bhaktinagar, JAY PRAKASH SAHA s/o acharul saha resident of jaganathpur, bidhannagar under p.s – phansidawa who are happens to be the partner of said rajat kumar guha and also introduced one RAJDEEP ROY (pochha) s/o Chitta Ranjan Roy of surya sen colony , block – c ward – 34 of smc under p.s – Bhaktinagar and DIP RAI s/o not known of nepali basti Bagdogra as manager and all the above named persons used to carry on their said travelling business through their office at Pakurtola more (ASHADEEP BUILDING) 3rd floor under the land lord Kailash Nandi and also form a office at sevak road beside Mober School.

It is painful to mention here that since last week we found that the aforesaid two offices of the culprits remain closed under lock and key and till this date the same is at it is. On further quarry we came to know that said RAJAT KUMAR GUHA and his aforesaid men are all traceless and they have committed such offence in respect of so many vehicles as listed below and in-spite of our best efforts we are not been able either to trace out our respective vehicles and the above named culprits.
