We came to know about the incident at 11:45 p.m. when we reached home. The grill of the kitchen which is at the backside of our house was broken, the entrance was locked from inside and the almira from which the articles were taken was open but rest everything was fine. We have found a rusted steel scissor inside the almira which is not ours. The details of the articles which have been thefted are:

- \*65 grams of gold jewellery
- \*Rs47,000 money in Cash
- \*Smart Watch

Therefore, I request you to kindly treat this complain report as an Fir against the incident and take necessary actions to resolve this matter.
