 and started to abuse me in vulgar languages
 and threatened me to withdraw the case.
 that I have filled against my husband and in-law.
 when I raised my voice my brother in-law Neeraj
 khatra caught hold of my shoulder pressing tightly
 pulling my top which my bra strap visible and
 also pulled my hair. He also snatched my cell
 phone being model No - Redmi 72 and threatened
 me to destroy my life if I don't withdraw
 the case. My husband also used unethical
 words to me in front of my brother which
 cheapened my dignity. Seeing this when my
 brother raised his voice my husband Manish
 Singhal and Neeraj khatra abused my brother
 with vulgar languages and took away my phone
 without returning me after several request.

From the above incident I am very
 scared and depressed. I request you to
 kindly look into the matter and provide me
 justice from the torture and abuse I have
 been through.
