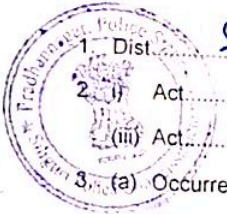

With due respect and humble submission, in producing herewith one accused namely (1) Nima Lama (28)S/O Amrit Lama of Penijhora ,Chalsa,P.S-Nagrakata ,Dist.Jalpaiguri under arrest along with following articles under proper seizure ;

- ii) 09(Nine) Bottle of Carlsberg Premium elephant strong beer , containing each bottle 650 ml
- iii) 05(Five) Bottle of Carlsberg Premium smooth Léger beer , containing each bottle 650 ml
- iv) 13(Thirteen) Bottle of Budweiser Premium king of beers , containing each bottle 650 ml

I ASI Debasish Das of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that on 23.03.2021 at 18:05 hrs myself along with force CV/131 Ranjan Sharma ,CV/128 Ajay Kr Sahani,CV/223 Swapan Chettri left from PS for Special mobile van duty vide PDN PS GDE No.1581 at about 18.15 hrs .During mobile duty I received a information that one person namely Nima Lama storage huge quantity of illegal liquor in his petty shop style as "Hornbill "satiated at Salbari under Pradhannagar PS and shelling the same in his shop .Accordingly I share the information to you and as per your kind instruction myself along with force rush to the spot and held raid above noted shop and detained the above noted person and on search his shop recovered above noted articles , On demand he failed to produce any valid document in favor of recovered articles .On interrogation he admitted that he shelling the same illegally without valid document for his illegal gain. Accordingly I seized & label the above noted articles in between 19.05 hrs to 20.05 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely (1) Nima Lama (28)S/O Amrit Lama of Penijhora ,Chalsa,P.S-Nagrakata ,Dist.Jalpaiguri and arrange for its investigation.
