With due respect, I, Smt. Usha Mahato, Wife of Harabnas Mahato, resident of Khalaibhaktari, Khopalashi, Post Office & Police Station Matigara, District Darjeeling-734010 (W.B.), beg to state as follows:

 That I am owner-in-possession of a vested land measuring 2 Kathas 4 Chhataks, in Khatian No. 01, L.R. Plot No. 1591, under Mouza Tumba, J.L. No. 78, Touzi No. 91, within Police Station Matigara, District Darjeeling and the possession of the said land was transferred by one Sri Indradeo Prasad Rajak.

2) That after acquiring the said land, I have been living in the said land by constructing premises with my family members.

- 3) That since last few days, said Sri Indradeo Prasad Rajak along with Sri Brahamdeo Rajak, Smt. Rani Rajak, Sri Kajal Rajak, Smt. Usha Rajak and Sri Sanjib Rajak have been creating disturbance in my peaceful possession and creating pressure upon me to quit and vacate the said land but when I raised objection, said persons abused me with filthy languages.
- 4) That on 22.11.2020, the above named persons forcibly tried to oust and evict me and my family members from my possession but when I raised protest, the above named persons abused me and assaulted me physically and also threatened me that they will oust me and my family members from the said premises forcibly.
 - That thereafter, I have filed an application U/S. 144 of Cr.P.C. before the Ld. Special Executive Magistrate at Siliguri vide Petition Case No. 89/2020 but the above named persons have not been complying the order of the Ld. Special Executive Magistrate at Siliguri.

That since 22.03.2021 at about 11:00 a.m., the above named persons came to my home and broken the boundary wall and also destroyed some household articles. But when I raised protest, the above named persons assaulted me with fists and blows and they have asked me to quit and vacate the said premises within 30.03.2021 and also threatened me with dire consequences and also threatened me that if I along with my family members be not vacated the said premises, our lives will be endanger.

That after such incident, I along with my family members are living in fear and apprehending that we may be attacked at any point of time by the above named persons and there is serious apprehension of breach of peace, public tranquility that may cause danger to human life and property or riot or affray in this locality.

So, I therefore, requested you to investigate the matter and take necessary legal action against the said Sri Indradeo Prasad Rajak along with Sri Brahamdeo Rajak, Smt. Rani Rajak, Sri Kajal Rajak, Smt. Usha Rajak and Sri Sanjib Rajak. And for this act of kindness, I shall much oblige to you.
