I, Suman Sengupta, Son Of Ashoke Sengupta, Assistant Engineer & Station Manager, Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India, would like to lodge a complaint regarding damage of electric lines and property of WBSEDCL. At Around 03:30 hrs on 24.03.2021 morning Power House Customer Care center received information regarding damage of electric lines in Netaji Nagar, Shivmandir, Behind Hotel Royal Sarovar, P.S Bhaktinagar, Dist- Jalpaiguri. On reaching the site, the maintenance van of Power House Customer Care Center found that one Truck having Vehicle no NL-01-AB-9149, had broken one Electric Pole and caused other damages to the Electric Lines which are the property of WBSEDCL. The total damages caused by the vehicle are approximately around Rs 21426/- (Rupees Twenty One Thousand Four Hundred And Twenty Six Only). Thus you are requested to kindly initiate an investigation against vehicle no NL-01-AB-5463 under Section 139 of the Indian Electricity act 2003 amended on 2007.
