In producing herewith one accused person namely Mahadev Sharma (58 Yrs), S/O Late Bishnu Dev Sharma of Sastrinagar, Ward No- 41, PS-Bhaktinagar, Dist-Jalpaiguri along with the following seized articles :

1. 20 (Twenty) bottles (12 Litres) of Himalayan Gold 60 up country spirit containing 600 ml. each , total value Rs- 2000/- (Rupees Two Thousand) manufacturing by Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal.
2. 30 (Thirty) bottles (9 Litres) of Boss 60 up country spirit containing 300 ml. each , total value Rs- 1500/- (Rupees One Thousand Five Hundred) manufacturing by Galaxy C.S Bottling Plant, Nagrakata, Jalpaiguri, West Bengal.

I, SI Md Ziaul Hoque of Bhaktinagar PS, SPC do here by lodged a written complaint against above noted arrested accused person that on 25.03.2021 at 22.25 hrs vide GDE No- 1633 received a specific input from the source that the above noted person has kept huge numbers of illicit liquor in his house in order to clandestinely dispose the same. Accordingly the fact is informed to I/C Bhaktinagar PS. As per his direction I along with Const-914 Sarat Thapa, Const- 1011 Rabi Sing Sonar and CV-946 Swapan Roy left for Sastrinagar, PS-Bhaktinagar, Dist-Jalpaiguri to verify the veracity of the information. On reaching there and as identified by source cordoned his house where he kept illegal illicit liquor. On arriving there found the above noted person who disclosed his identity as noted above and on search found huge numbers of country made spirit at his shop in conceals position. On being interrogation he could not produce any valid documents in respect of the said illicit liquor. He also stated that he is doing this liquor business since last 06 months for wrongful gain.

Accordingly I seized the same in presence of witness as per proper seizure list duly signed by the witnesses. The seizure was made in between 22.45 hrs to 23.05 hrs. On being asked he stated that he kept the same with a view to sale without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him after observing all sorts' rules for selling the said country made spirit without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accused namely Mahadev Sharma (58 Yrs), S/O Late Bishnu Dev Sharma of Sastrinagar, Ward No-41, PS-Bhaktinagar, Dist-Jalpaiguri as per proper section of law.
