I, PSI Shekhar Adhikary of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one named Manahar Roy to the effect that today on 27/03/2021 at 19:45 hrs while performing evening patrolling duty, received a source information that one person named Manahar Roy is selling liquor in his tea shop situated at Thakkar under Matigara Police Station without any valid license . Accordingly I informed the matter to the O/C PS and as per his kind direction myself along with C/1008 Kanak Roy, CV-387 Sukumar Barman, CV-155 Sukumar Das had been to Thakkar under Matigara PS to verify the veracity of the information. On reaching there and as identified by the source it found that one person was selling something to some people at the alleged Shop. Subsequently, I along with my force cordoned the shop and moved toward the Shop and seeing police team the customers who were having liquor at the alleged shop managed to flew away from the back side of the tea shop but we abled to detained the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in the said tea shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 06(six) months for his illegal gain. Then I seized and labeled the above mentioned liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Manahar Roy (40) S/O- Jogeswar Roy of South Ambedkar colony PS-Prodhan Nagar, Dist- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 20.05 hrs to 20.25 hrs at the spot and arrest issued memo of arrest at 20:25 hrs. against him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Manahar Roy (40) S/O- Jogeswar Roy of South Ambedkar colony PS-Prodhan Nagar, Dist-Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
