Sir,

With due respect, I am producing herewith the arrested accused person namely Mantu Roy S/O late Kista Mohan Roy of Thangbhanga More, Madani Bazar, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 27 (Twenty seven) bottles of 60 up Himalayan Gold Country Spirit containing 600 ML in each bottle of Rs 100/- of each bottle.
2. 02 (Two) bottles of Old Monk XXX Premium Rum containing 375 ML in each bottle of Rs 320/- of each bottles.
3. 03 (Three) bottles of MC Dowel's No-1 Celebration Matured XXX Rum containing 180 ML in each bottles of Rs 153/- of each bottles.
4. 09 (Nine) bottles of Old Monk XXX Premium Rum containing 180 ML in each bottle of Rs 153/- of each bottle.
5. 01(One) bottle of MC Dowel's No-1 Celebration Matured XXX Rum containing 750 ML in each bottles of Rs 640/-.

I beg to state that today i.e. on 27.03.21 at 22.10 hrs I received a secret source information that one person named, Mantu Roy of Madani Bazar is selling ID liquor at Thangbhanga More, Madani Bazar without any licence for his wrongful gain and he stored huge quantity of ID liquor at his residence at Madani Bazar. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 1374 dated 27.03.21 and informed the fact to you. As per your kind direction and instruction myself along with force left for Thang Bhanga More, Madani Bazar to work out the information in hand. At about 22.35 hrs we arrived at Thangbhanga More, Madani Bazar and being identified by the source I Held raid at the house of Mantu Roy S/O late Kista Mohan Roy of Thangbhanga More, Madani Bazar, PS- NJP, Dist.- Jalpaiguri and apprehended him. During interrogation he disclosed his name and address as noted above and admitted his guilt and also disclosed that he is selling ID liquor at his residence at Thang Bhanga More for his wrongful gain. During search the above noted ID liquor found hidden in his bed room. On demand the said accused person failed to produce any valid documents/licence in respect of the above noted ID liquor recovered from his possession. Accordingly, I seized the same under proper seizure list and arrested the above noted accused person under proper memo of arrest and observing all the formalities of arrest. The process of search, seizure and arrest made in between 22.35 hrs to 23.05 hrs on 27.03.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the above noted arrested accused namely Mantu Roy S/O late Kista Mohan Roy of Thangbhanga More, Madani Bazar, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
