Sir,

With due respect I am submitting a written complaint against one Female accused namely Debi Rana (43) W/O Raju Rana of Lumbu busty,Prakash nagar,W/no-42 PS-Bhaktinagar Dist-Jalpaiguri and producing herewith the following seized articles as per proper seizure list:

1. One (01) Bottles of Royal Blue Premium whisky containing 750 ML).
2. Seven (07) Bottle of Himalayan Gold Country sprit (each bottle containing 750 ML)
3. Two (02) Bottle of Himalayan Gold Country sprit (each bottle containing 300 ML)
4. Four (04) Bottle of Sikkim XXX prize rum (each bottle containing 180 ML)
5. Two (02) Bottle of Mc Dowells No-1 celebration XXX rum (each bottle containing 180 ML).
6. Four (04) Pouch of Officer choice prestige whisky (each bottle containing 90 ML)
7. Six (06) Pouch of Mc Dowells no -1 celebration XXX rum (each bottle containing 90 ML)
8. Four (04) Pouch of Mc Dowells no -1 celebration XXX rum (each bottle containing 180 ML)

I, ASI Rabin Lama of Bhaktinagar PS,SPC lodged a written complainant against the above noted person to the effect that today i.e. on 27.03.2021 at 21.35 hrs received a source information that at the house of Debi Rana (43) W/O Raju Rana of Lumbu busty,Prakash nagar,W/no-42 PS-Bhaktinagar Dist-Jalpaiguri have gathered huge amount of liquor illegally inside his house for selling the same in the customer for her wrongful gain. This refers to Bhaktinagar PS GDE no- 1743 dated 27.03.21. I informed I/C Bhaktinagar about the information . As per his kind instruction I along with C/ 762 Majibur Rahaman and CVF/619 Dharmendra Roy as proceed to Prakash nagar to work out the information. At 21.55 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the house of Debi Rana (43) W/O Raju Rana of Lumbu busty,Prakash nagar,W/no-42 PS-Bhaktinagar Dist-Jalpaiguri and recovered the above noted articles from the house and one female fled away from the house after seeing the police party and it is learnt from the witnesses that one female namely Debi Rana (43) W/O Raju Rana of Lumbu busty,Prakash nagar,W/no-42 PS-Bhaktinagar Dist-Jalpaiguri selling the same in the customer and after seeing the police party she fled away from her house and also learnt that she sell the same in the customer since long for her wrongful gain without any valid documents. In presence of available witnesses I seized the above noted articles from the house after preparing proper seizure list and took signature of the witnesses. The seizure was made between 22.55 hrs to 23.05 hrs.

I therefore request you a specific case may kindly be started against the accused person namely Debi Rana (43) W/O Raju Rana of Lumbu busty,Prakash nagar,W/no-42 PS-Bhaktinagar Dist-Jalpaiguri under proper section of law.
