
- (1) 17 bottles of Himalayan Gold country sprit, containing 600 ml each bottle

I ASI Ratan Pradhan of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that on 28.03.2021 at 21:05 hrs myself along with force CV/131 Ranjan Sharma, CV/128 Ajay Kr Sahani, CV/223 Swapan Chettri left from PS for Special Holi mobile van duty vide PDN PS GDE No. 2011 at about 21.15 hrs. During mobile duty I received a information that one person namely Gopal Sah storage huge quantity of illegal liquor in his shop style as "Ganesh Hotel" situated at Siliguri junction under Pradhannagar PS and sell the same from his shop. Accordingly I share the information to you and as per your kind instruction myself along with force rush to the spot and held raid above noted shop and detained the above noted person and on search his shop recovered above noted articles. On demand he failed to produce any valid document in favor of recovered articles. On interrogation he admitted that he is selling the same illegally without valid document for his illegal gain. Accordingly I seized & label the above noted articles in between 21.50 hrs to 22.35 hrs and arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Gopal Sah (25) S/O Lt. Ramji Sah of Nichey Busty, Panchanan Colony, P.S- Pradhan Nagar, Dist. Darjeeling and arrange for its investigation.
