I am Asif Karim, S/O - MD Nurul Haque. Currently residing at Bikan Mone, Behind Mahina's Hotel. On March 29, 2021, Time 6:30 PM.

We were going through the wood of Panighota, so there were some boys drunk. Suddenly stopped us and starting hitting us and they were trying to attempt murder on all of us. And my right eye got injured badly. One of them had bitten on right hand and took out the flesh.

We were five boys, Nawin Xalko, Biki Sha, Romit Dey, Dipon Jor. The boy named Ajay Mahato, Akash Singh and Tony more had started trying to kill us all.

I shall be obliged if you kindly take action and take sincere steps because I have faith in Constitution and Indian Law.
