Today morning around 10:30 am when I came to
my mother's Residence which is situated at S.P.
Mukherjee Road, Siliguri, I found that the main
gate was locked from outside which I opened with
my spare key. After entering the compound

I found that gate of the room was closed from
outside wherein our maid cum caretaker of the house
was residing namely Anita Das aged about 60 years
and she was found dead lying on the bed. All
valuables and cash were missing from almirah
which was broken. After seeing all this we

intimised other family members and then police
for their necessary action. I think someone has
murdered her and stolen away valuable articles like
gold jewellery, silver jewellery and cash.
