Sir,

With due respect I, Sri. Srikanta Paul, son of Nitai Chandra Paul, being the Joint-Secretary of Naba Tarun Sangha (NTS Club), NTS More, Deshbandhu Para, Siliguri-734004, District- Darjeeling, would like to inform you that since last few months one person namely Kanhaiya Raut resident of Railway Quarter at Tikia Para, SMC Ward No.28, Siliguri are creating nuisance entering into our Club Room premises (although he is not a member of our club). As a result of which there was a tension amongst our members. 10-15 days ago, few of our members requested him not to enter the club room premises without permission. He became angry and broke a plastic chair and table at that time. Thereafter, all members of the club pushed him out of the clubroom and requested him not to come again to the vicinity of the club.

Today, at about 4:00pm said Kanhaiya Raut alongwith 4 (four) others armed with Iron Rod, Wooden piece (Battam) forcefully entered the clubroom, vandalized the clubroom and assaulted our members Sri. Sanjay Pandey and Bijay Prasad with such Iron Rod and Battam with an intention to kill them, as a result of which our aforesaid members received severe/grievous injury. Thereafter, again at about 6:00pm, in my presence, said Kanhaiya Raut alongwith 6-7 Persons again assaulted said Sanjay Pandey and Bijay Prasad near the club premises with iron rod, etc.

Said Kanhaiya Raut also threatened me and Sri. Sanjay Pandey and Bijay Prasad that if any person lodges any complain against them he will go to the house of all of us alongwith more person and will assault us in front of our family members.
