Jalpaiguri, P/S Bhaktinagar under SMP like to state that yesterday evening at 3pm my younger daughter Saraswati Subba age 16 went missing from home and we looked her everywhere till today morning but couldn't find her. We tried to contact her phone but she had switched off her phone. Today at 2:50 pm a local boy name Siddharth Biswakarma s/o late Ganesh Biswakarma old resident of Salugara Bazar near Hamro Hotel and presently working as a labour at Lama Hardware situated at Salugara Bazar called on Dipika Das phone number 7719356621 as she told her that Saraswati Subba is with him and told her to say her father do whatever you can, you won't be able to do anything against me and denied to return back my daughter.

My family fear about Saraswati Subba's life and request you to take quick action to find my daughter as soon as possible.
