I Shri Amit Lama Sherpa s/o Pradip
Lama Sherpa resident of Salugara Bazar,
dist. Jalpaiguri, P/S Bhaktinagar under S.M.P.
like to state that yesterday evening at 3pm
my younger daughter Apeksha Lama Sherpa
age 15 went missing from home and we
looked her everywhere till today but couldnt
find her. But Siderth Biswakarma s/o late
Ganesh Biswakarma old resident of Salugara
Bazar near Hamro Hotel and presently working
as a labour at Lama hardware situated at
Salugara Bazar called on Dipika Das
phone number 7719356621 as he told her
that Apeksha Lama Sherpa is with Lakpa
Tamang as well as Saraswati Subba and
Siderth Biswakarma they four of them are
at the same place. But sir my daughter
is minor in age.

Sir I think these two boys are adult
in age so I think they are in contact with
human trafficking.

Therefore, my family fear about
Apeksha Lama Sherpa's life and I would
like to request you to take quick action
to find my daughter as soon as possible.
