Sir,

I, **SMT SHYAMALI SAHA**, Wife of Sri Uttam Kumar Saha, resident of 115/2, Saradamoni Road, Haider Para, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to draw your kind attention to the effect that tonight at around 9.30 PM 1) Biplab Saha, Son of Bimal Saha, owner of Bimal Sweets, Hati More, Subhash Pally, P.S. Siliguri, Dist. Darjeeling and 2) Aniruddha Saha @ Biltu, Son of Biju Saha, of Pakurtala More, Opposite to Ramkrishna Seva Sadan Nursing Home, P.S. Siliguri, Dist. Darjeeling came at my above addressed house and called on my only son namely Kushal Saha and accordingly my son went out from house, thereafter without spending any word the above culprits started to beat my son brutally with the aid of rod, wooden stick and by seeing so, my husband tried to resist them. Then they also beat my husband mercilessly with such aids. Thereafter they intentionally dragged me and pulled me down at the road and most desperately pulled out my wearing apparels and disrobed me in public road with an intention to outrage my modesty and they succeeded to do so. They also beat me with the aid of deadly weapons as a result of which I received grave injuries at my knee and hands. During the said incident, the above culprits snatched my necklace measuring 40 Gm. I along with my husband and son got grave bodily injuries and due to our shouting local people went out at the road and the above culprits fled away from the place with the further threatening to kill us soon. Thereafter We got treated with medical aid (Medical papers are enclosed herewith). Moreover, there is every apprehension of further deadly attack upon me and my family by the above culprits, as they have oblique motive to kill our family member, so I along with my family are living under the panic and mental agony of harm to our life and limb by the said culprits. It is really a hardship that the above culprits did the said desperate unlawful act/s and disrobed me in public and beat my husband and my son with deadly weapons and still roaming in open space by showing thumb to the law of the land, so there is a need of getting them behind the iron bars is required with immediate effect.
