Respected Sir / Madam,


I Sri Biswajit Das, S/o. Sri Bikash Chandra Das, R/o. Prakash Nagar, **Sahani Basti**, Ward No.43, P.S. Bhaktinagar, Dist. Jalpaiguri would like to inform you that yesterday i.e. on 29/03/2021 at about 10.30 p.m. when I loitering in my locality at that time one person namely Mastan Singh came in front of me with drunked condition and after coming in front of me he started to used slam languages in respect of me as well as in respect of others persons when I tried to protested the same at that time he called his other associates namely Sumit Singh, Raju Paswan, Avishek Paswan, Bablu Singh, Raj Karan Singh, Sushil, Rambabu Paswan and others and after that they all of them without any reasons they started to assaulted me by using **LATHI AND BAMBOO** and at that time after listening my hue and cry my friends came to the spot at that time the above noted persons intentionally used **VOJALI** and tried to kill me and after assaulted by them I became senseless and also sustained multiple injuries on my whole body specially in my head but due to marcy of god or my friends some how they rescue me from their hands and immediately took me at Siliguri Sadar Hospital and attending doctor advised me for stich and it is also important to mention here that at that time the above noted persons also threatened me with dire consequences and told me that if I intimated the aforesaid facts to any authority then they will kill me on road so, right now I spend my days very bad condition and at the time of said incident the above noted persons intentionally took a sum of Rs.5,000/- (Rupees Five Thousand) Only from my chest pocket and also they took one gold chain from my neck (15 gm.) so, no other alternative way today with the help of my well wishers I lodged this written Complaint before you.

Therefore, I request you be pleased to draw your kind attention in respect of my above noted written Complinat and take necessary steps against the above noted persons as early as possible.
