This is to inform you that I, **SRI, RAJIB ROY**, Son of Kali Roy, Resident of Majhabari, Dabgram-2, P.S: Bhaktinagar, District: Jalpaiguri, PIN: 734006. That I have filed a civil case before the **Ld. Civil Judge (Junior Division)** at Jalpaiguri being **T.S No: 258/2020** and the Ld. Court was pleased enough to pass restrained order against the opposite party /accused person by way of an ad interim injunction and directing the opposite party /accused person not to enter into the suit land and also not to disturb the peaceful possession of my below mention Schedule Property.
