Respected Sir,

I, **ROHIT CHHETRI**, S/O Sanjib Chhetri, R/O Rajiv Nagar, Darjeeling More, P.O. & P.S. Pradhan Nagar, Dist Darjeeling, do hereby like to inform you as follows :-

1. That I lodge this FIR to the effect that I am the permanent resident of the above named address.
2. That on 28.03.2021 at night some persons namely **1. SANJIT SAH**, S/O Late Baidnath Sah, **2. PRABIN SAH**, S/O Late Baidnath Sah, both are resident of Rajiv Nagar, Darjeeling More, P.O. & P.S. Pradhan Nagar, Dist Darjeeling **3. RANJIT SAH**, S/O Late Baidnath Sah, resident of Methi Bari, Salbari, P.O. Salbari, P.S. Pradhan Nagar, Dist Darjeeling, came with the bike in front of the house of one Bidyut Das in fully drunken condition and started to accelerate their bikes together by making huge nuisance in front of my house.
3. That upon this when I along with my friend Bidyut Das, S/O Narayan Das (now deceased) protest against these kind of illegal activities of the above noted persons **1. SANJIT SAH**, S/O Late Baidnath Sah, **2. PRABIN SAH**, S/O Not Know, **3. RANJIT SAH**, S/O Not Know started to abuse me in filthy languages and called more of their anti-social associates with the sharp weapons.
4. That I along with one Bidyut Das, S/O Narayan Das (now deceased) also told the said above noted persons that this huge accelerator sound is affecting the father of Bidyut Das, S/O Narayan Das (now deceased) as he is a patient of cardiac arrest and he may die but upon this the above noted persons became more furious upon me and Bidyut Das, S/O Narayan Das, they started to hit me and Bidyut Das, S/O Narayan Das (now deceased) with kicks and blows and also used the sharp knife to kill the me and Bidyut Das, S/O Narayan Das (now deceased).

That subsequently one of our friend namely Pritesh Chhetri, S/O Samir Chhetri who had come to rescue us from the hands of the above noted persons the said **SANJIT SAH**, S/O Late Baidnath Sah, started to beat him mercilessly and kicked him on his lower abdomen which was already injured and the said injury is still persisting.
6. That after seeing this when the mother of Bidyut Das, S/O Narayan Das came running towards the fight to save me and Bidyut Das, S/O Narayan Das from the above named accused persons, the said accused persons pulled my mother by pulling our hair and torn our apparels and started to beat her mercilessly in front of others and when I tried to save myself from the hands of the accused persons they also attacked me by hitting me on my arm, neck and head, and by pressing her chest.
7. That subsequently due to the continuous heavy sound of the accelerator of the bikes of the above noted persons the father of the Bidyut Das, S/O Narayan Das died due to heart attack on the spot.
8. That during this fight the above named persons cut the top of the little finger with the knife, kicked Bidyut Das, S/O Narayan Das on his forehead and the above noted person also snatched a gold chain from my neck and a cash amounting Rs. 8000/- (Rupees Eight Thousand) only.
9. That the above named accused persons looted me and attacked me and my friends family members with an intention to kill us. The above named accused persons not only try to kill me and my family members but also disrobe my modesty by tearing my apparels and took pictures of the same.
10. That the above named persons are very much desperate in nature and continuously threatening us that they will take revenge from me and they will kill me and my friends and family members and they may also implicate us in false cases.
11. That still those accused person are too much desperate in nature, not allowing us to stay in my house peacefully and as a result we has to spent our days as bewildered condition and the life and dignity and honour of us are in danger and we are passing our days with great fear/tension/anxiety for the continuous threat given by above named accused persons.

12. That I am a helpless lady and seeking justice from you by taking necessary legal action against the above named accused culprits and take the necessary legal steps as our life are in very much danger and the above named accused persons can any time attack us.

Therefore under the above mentioned circumstances I request before your good self to kindly look into the matter and take necessary action against the aforesaid persons as per the provision of law, otherwise they may rape my daughters or may kill us at any time as they are very much desperate in their activities and for this act of kindness I shall remain extremely grateful to you.
