Sukumar Sarwan residing at Durga Nagar Colony, Kumartali within ward no. 4, SMC P.O & P.S - Siliguri District - Daryeeling, would like to inform you that on 28/03/2021 at about 4:00 P.M. when me and family are all at home. At that moment I heard a very loud noise in my gate and I saw a dog quickly enter my house through my gate at that time me and my younger son Sri Gauranga Sarwan come out of the gate and ask who throw a stone at my gate, then two persons namely Sonjay Sahani and Dipu Sahani came and told me that we throw the stone and what will you do to us, and they both are confidently said that our father is in jail and they kill us and happily going to jail and they also say they are fully sure that they are released after three months. After that at about 8:00 P.M and 11:00 P.M they came several times with some boys with force and kicked my gate and they using dirty languages

in the name of me and my elder daughter. They threatened us with dire consequences. At this I became panicky and in future if anything will be happened against me and my family then he will be liable and responsible for the same. your good office is therefore requested to do the needful and take appropriate actions.
