Bongaiburg, do hereby inform you that, on dt 29-03-2021 at about 02-30 P.M., the following persons entered into my brother, namely Roshan Roy's quarter at Maharij colony, ward No. 4 SMC, P.S.-Siliguri, namely (1) Harna Sahani @ Not known s/o Not known (2) Dipak Sahani & (3) Sunjay Sahani, both sons of Sri Harna Sahani @ Not known s/o Not known, all are of Maharij colony, ward No 4 SMC, P.O.-Siliguri Bazar, P.S.-Siliguri along with (4) Paawan Sah s/o Sri Umesh Sah of Santoshi Nagan, Near Isak Mandir, ward No-5 SMC, P.O.-Siliguri Bazar, P.S.-Siliguri, with wooden log (Botaun) and sharp cutting metal knife in their hands, and suddenly attacked on me with it and beaten
