vulgar language on me with threatening of my life and also
one of my staff also beaten by him, In that moment he
snatched approx 17,000 rupees from my cash box and broke
my sweet show case of my shop, that's why lots of sweets
damage for that incident.

Today (30.03.2021) timing approx 1:30 PM
brother of Kanaya Routh named Manish Routh came to
my shop very aggressively and same kind of vulgar language
uses to my staff he also threatening us if we blamed
diary about this incident.
