Respected Sir,

I, Sri Suraj Rajak, Son of Kripan Rajak, Resident of Bagrakote, Durgadas Colony, Ward No.20, P.O & P.S- Siliguri, District-Darjeeling, would like to inform you that on 28.03.2021 at around 6.30 p.m. my mother Smt. Sudhira Rajak, wife of Kripan Rajak along with her granddaughter Miss. Suniya Rajak, Daughter of Sibu Rajak, were returning from the Railgate Bazar, when they reached Chittaranjan Colony, Bagrakote, one Red colour (ACTIVA) scooty bearing Registration Number WB74AM2933, came in a very rash and negligent manner and hit my mother from the front which led her to immediately fall in the drain beside the road. My mother suffered major fracture on the Right shoulder due to the said accident and also sustained severe injuries on her face and lied unconscious. It is pertinent to mention here that the said scooty was being plied by one driver and one pillion rider who had crashed on the side of the road. The local people gathered and helped my mother out of the drain and immediately informed our family members. The local people who stood witness to the incident caught hold of the said driver and his pillion rider and they were suspected to be drunk by the local people. Soon the said driver and the pillion rider escaped from the spot and fled the premises. Upon hearing about the said accident, I immediately rushed to the spot and took my mother to Siliguri District Hospital where an X Ray was conducted. Thereafter, I took the X Ray report and I shifted

my mother to a nearby nursing home Basu's Clinic Healthcare Pvt. Ltd. on the same night. Thereafter on 29.03.2021, she was operated. It is pertinent to mention here that a 3 hole plate fixed with 6 screw proximally and 3 screw distally has been fixated at the right shoulder which will remain in her shoulder throughout the entire lifetime of my mother. The said fracture is so greivous in nature that the damage is permanent. My mother suffered the aforesaid injuries due to the rash and negligent act of the driver of the scooty. It is relevant to mention here that due to the said accident my mother is severely injured and is currently undergoing treatment at Basu's Clinic Healthcare Pvt. Ltd.

Hence, I humbly request you to investigate in the matter, and take necessary action against the said culprit driver of the Scooty bearing Registration No. WB74AM2933 in accordance to the appropriate provision of criminal law.
