Nurul Haque, <sup>of Bikaner more,</sup> ② Biky Sha, ③ Dipak ④ Ronit, ⑤ Navin and more others came with Motor cycle in intoxicated condition and stop near of us and suddenly hit me when my father came to stopped them, then they biter up my father badly thereafter they fall me and my father into the floor and started kicked us and then take a rod (Iron) and Beater up badly me and my father, when my sisters, aunties came to save us then they slapped my sister and molested them (my sister & aunties). Thereafter when ~~the~~ my friend namely Akash Singh try to stoppe them they also beater him. Thereafter when I sought for help, then ~~the~~ my freind and neighbours came to protect us then the all persons above named run out with their Motor cycles. Now my condition and my father's condition is very miserable and father's left leg is already fractured broken (slightly). They Threter us that they will definatly kill us. ~~Now~~ Now we were be Horrified about our life.

It is request before you kindly take a legal acti against them as soon as possible.
