At Around 00:30 hrs today on 31.03.2021 morning the undersigned received information regarding damage of electric lines near Kothari Goli, Salugara, Siliguri, P.S Bhaktinagar, Dist- Jalpaiguri. On reaching the site It was reported by Technical staff that, one Truck having Vehicle no CG-04-JC-7512, While driving had broken Electric Pole and caused other damages to the Electric Lines which was the property of WBSEDCL. The total damages caused by the vehicle is approximately around Rs 43812/- (Forty Three Thousand Eight Hundred Twelve Rupees).

Thus you are requested to kindly initiate an investigation against vehicle no CG-04-JC-7512 under Section 139 of the Indian Electricity act 2003 amended on 2007.
