Reg: An attempt of theft & vandalised the E-Zone of three machines placed for customer service on 24x7 hrs at our Hill Cart Road, Siliguri Branch (e-UBI).

I, Sri Ved Prakash, Branch Manager of our Hill Cart Road, Siliguri Branch (e-UBI) son of Sri Banshidhar Prasad am hereby reported to you that in the last night on 31<sup>st</sup> March 2021 at around 01.15 AM, an attempt of theft and vandalised all the 03 machines installed in the e-zone by the miscreants was undertaken.

Our e-zone adjacent with our Siliguri Branch (e-UBI) is functional on 24x7 hrs basis for customer service which is just opposite to Hongkong Market. There are 03 machines installed in the e-zone. Those are ATM, Coin Vending machine and multifunctional kiosk machine. Miscreants have tried to open all the machines and vandalised. However, a lower panel lock of ATM is missing. Vendor has been informed to assess the vandalism or any cash loss, if any.

Under the circumstances, we would kindly request you to take necessary steps to overcome the situation as you are deem fit and proper. This is for your kind information and it will be treated as FIR regarding the matter. Pen drive of CCTV footage is also enclosed for your ready reference and further investigation.
