I would like to lay following few lines for favour of your kind consideration and necessary action:

That one Sri Handa Ram Chettri, Son of Ganga Prasad Chettri of House no.22, Lower Balyadgang, Village Upper Balyadgang (Galmi Goan), Sub-Soreng, Dist-West Sikkim having mobile no. 90834-40102 Checked in our hotel on 27/01/2021 and left the hotel on 01/03/2021 with keys of the room provided to him without giving any intimation to us and without paying the room rent as well as fooding and other room service charges.

It is pertinent to mention here that the said Sri Handa Ram Chettri booked one room in our hotel on 07/02/2021 for one lady namely Priya Rawat wife of Ishwar Rawat resident of upper Sichey, MW, Bye pass road, near Shishu Bhawan, Sichey area, Gangtok Municipal Corporation, Upper Sicheygoan, East Sikkim having Mobile no.92051-29961.

That the said lady checked in separate room on 07/02/2021 at about 8:00AM and checked out on the same day at about 11:30AM and the above named Sri Handa Ram Chettri assured and promised that he shall pay the Room Rent including fooding and other charges.

That on many occasions the said Sri Handa Ram Chettri has also booked other rooms for his friends but he did not pay any amount to us though promised.

That the said Sri Handa Ram Chettri, Priya Rawat and unknown friends of Sri Handa Ram Chettri have jointly cheated us and have escaped from the hotel without any payment and intimation which is punishable under law of land.

That a sum of Rs 64955.00 (fifty four thousand nine hundred fifty five.) is receivable by us from Sri Handa Ram Chettri.

Therefore, I am requesting you to accept this First Information Report and to take necessary legal action against the above named persons for their punishment as per provisions of law and for recovery the dues amount at the earliest and oblige.
