I, Smt. RANJU MISHRA, W/o Sathayan Mishra,
resident of Hemanta Benu Colony, PS-Siliguri,
Dist-Darjeeling, do hereby solemnly affirm and
declare as follows :-

1. That on 23.03.21 at about 4.00 PM when I am
in my house at aforesaid address at that time
some persons namely 1) Patel Mishra, S/o Lt.
Ghanshyam Mishra, 2) Jitesh Jha, S/o Binay
Jha, 3) Rabi Mishra, S/o Patel Mishra - all
are resident of Hemanta Benu Colony, P.S.
Siliguri, Dist-Darjeeling all of sudden enter
into my house and assault me with fist and
blows and by kicks and when my son namely
Sarbhan Kumar Mishra came there to save me
then they all started assaulted my said son
also with lathi & bricks and injured my said
son grievously and blood oozes out from the
nose of my said son and I also got severe
injury on my head. Thereafter with interven-
tion of neighbour I and my said son was
rescued and treated by doctor at SD Hospital
Siliguri so the delay for lodging the F.I.R.

That the above named person are very dangerous
and desperate in nature and at any moment he
kill me and my family and also restrains me
to make boundary of my land.

So, I therefore kindly request you to investi-
gate into the matter and take necessary steps
against them.
