Rabindra Sarani as well as the owner of Hotel Golden Moments, Saffdar Hashmi Chowk, SMC Ward No. 6, 143 Hill Cart Road, Siliguri P.O. & P.S. Siliguri -734001 like to lodge a F.I.R. against some miscreants (approx 10-12 persons) who are tried to enter my hotel forcefully at about 12.40 a.m. today when hotel main gate wooden shutter was closed from inside and collapsible gate was duly under lock and key. They knocked the door my night staff Sri Bikky Deb opened the wooden door the miscreants wants to enter the hotel Bikky Deb expressed that he will not agree to allow them to enter the hotel as they have not possess any luggage with them, one of them assaulted the Bykky Deb by catching his hare. Collapsible gate has also been broken.

Sir, I am about 62 years old and suffering from hyper tensions. this incident heated me severely. Bhojohari Manna Restaurants is also situated in the 2nd floor of this hotel. hard cash was kept in their cash box - I am feeling unsecured in this incident. Shri Suhongsu Sarkar of JSS Security deployed by my neighbor Shree Shyam Cellular was present in this time.

I am sending here a pen drive from which you will find the CCTV footage of the incident. Further detail may be have with neighbors CCTV Hard disk.

Sir, Kindly help me to arrest the miscreants immediately and help me to run the business peacefully considering the present Covid situation.
