Sub: Complaint regarding blackmailing and extortion

Sir,

I, Kushal Agarwal, son of Late Binod Kumar Agarwal, resident of Landmark Residency, Bankim Nagar road, Near Shiv Mangal School, Ward No. 41 of S.M.C., Sevoke Road, Siliguri – 734001 begs to state you that about a year ago in the month of December, 2019 I had a talk on "Instagram" with a user whose profile name was Shristi Goyal from my Instagram Account (@kaaa.12agn earlier @kushalagarw). After having a friendly conversation, we started having a friendly conversation, we had started having an intimate conversation. That after taking for a substantial period of time, the holder of the account named Shristi Goyal asked me to share my full figure by way of video to see how handsome and masculine I am. And I did send the video and after that the conversation did not continue and came to an end.

Suddenly after few months, on 22nd July, 2020, I received a call from an unknown man (he said his name is Rahul) who said that he was the user of the account named Shristi Goyal and he started threatening me. He used to say that he will share my morphed images and doctored videos on social networking platforms and make them public if I do not pay him Rs. 3100/-. Frightened by the threats I sent him Rs. 3100/- on 22nd July, 2020 through Google Pay to UPI Id. Amanagarwal9165726@oksbi. Thereafter, he made a practice of blackmailing me on regular intervals to extort money from me and in the same manner he asked Rs. 10,000/- on 12th August, 2020 that was again deposited through Google Pay to UPI Id. Amanagarwal9165726@oksbi thereafter on 1st October, 2020 he asked a sum of Rs. 10,500/- which was deposited on his direction in two accounts one Rs. 5500/- to "Phone Pe" account being mobile no. 90398-70433 and another Rs. 5000/- through Google Pay to UPI Id. Lileshagarwal120@okicici. Further, on 29th November, 2020 he asked to deposit rs. 7500/- and said that this is the final time he is asking for money and after I give him this money he will never ask anything and so, I deposited the money to his account through Google Pay to UPI id. yashhinduja15@okaxis.

Then again on 19th January, 2021 he again started calling me on my phone but I had stopped attending the calls after few refusals to answer the call he stopped calling me. But on 9th February, 2021 he called again and demanded a sum of Rs. 15000/- which was deposited as per his direction through Google Pay into two accounts; Rs. 5000/- to UPI Id. Gopal130102@oksbi and Rs. 10000/- to UPI id. yashhinduja15@okaxis.


Therefore, under the above circumstances I would humbly request you to kindly take necessary action against the aforesaid unknown person.
