- iv) One Hyundai Aura Car bearing Reg. No-WB-74 BE/7082


I SI Dilip Kr. Paul of Pradhannagar PS, SPC lodging this complainant against the above noted arrested person to the effect that on 01.04.2021 at 17:05 hrs while myself along with force& SST Team Election Cell-2021 were performing Naka Checking Duty in c/w ensuing general assembly Election 2021 on NH-31 at Champasari near State guest House more Vide PDN Ps GDE No-37 dated 01.04.2021, I stopped one Hundai Aura car bearing Reg. No-WB-74 BE/7082 which was coming from Bhaktinagar side towards Pradhan Nagar PS area being driven by above noted arrested person. During checking of the vehicle I found 04 cartons which were kept in the dicky of the car. On search I could found above noted incriminating articles. On being asked the driver of the vehicle disclosed his identity as noted above and failed to produced any valid documents and reasons against the carrying of such liquors. There was a reasonable believe arose that he procure, carrying the liquors illegally for influence the election procedure/ voters or any other illegal motives. Thus, I seized the above noted foreign liquors along with car in presence of members of SS Team, Election cell -2021 from 17:45 to 18:35 hrs and arrested the above noted person after observing all the formalities. During interrogation said person admitted that he procure the foreign liquors from Bhutan and transporting to Siliguri via Sikkim for illegal reason.

Therefore, I pray before you to register a specific case against said Krishna Prasad(49) S/o It. Sarabjit Prasad of Arityhan Near IDBI Bank A.K Gupta Wine shop, Gantak , East Sikkim under proper section of law and arranged for its investigation.
