Most Respectfully, I ASI Maksud Ali of Pradhan Nagar PS ,SPC lodging a complaint against the rider of the offending vehicle bearing Reg. No- WB 74 AJ 4469 to the effect that on 30.03.2021 during my patrolling van duty after receiving an information of accident from duty officer I along with force had been to Mallaguri near Hunuman Mandir and it could be learnt that one Scooty bearing Reg. No. WB 74 AJ 4469 dashed one female person as a result she received serious injury on his person and shifted to Siliguri District hospital by the local people. Then I visited Hospital and contacted with patient as well as attended doctor. Subsequently on 31.03.2021 I received information that the patient was expired Siliguri Hospital and over this a UD case was started vide Siliguri PS U D Case No. 120/21 dated 31.03.2021.

Therefore, I pray before you to register a specific case against the rider of the offending Scooty bearing Reg. No. WB 74 AJ 4469 under proper section of law and arranged for its investigation.
