Sir,

In producing herewith one (01) arrested accused person namely Abdur Rasid (48) S/O - Lt. Khalilur Rahaman of Fatepur, PO. Maya, PS- Lalgola, Dist. Murshidabad (not verified) along with the following seized article under proper seizure as per seizure list;

- a) One transparent plastic packet containing 200 grams brown sugar which was kept on the right side Pocket of trousers of accused Abdur Rasid and marked as "Exhibit- A"
- b) One transparent pouch containing 20 grams brown sugar taken as sample from exhibit "A" for examination and marked as Exhibit "A-I".

I, SI Shekhar Adhikary, S/O- Sonatan Adhikary of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person namely Abdur Rasid (48) S/O - Lt. Khalilur Rahaman of Fatepur, PO. Maya, PS- Lalgola, Dist. Murshidabad (not verified) to the effect that today on 06.04.2021 at about 06.05 hrs I received a specific source input that one person is standing at Biswas Colony More under Matigara PS with huge quantity of Brown Sugar for delivering the same to his designed customers at the adjacent areas. The matter was diarized in Matigara PS GDE No. 253, Dt- 06.04.2021 and subsequently, I informed the matter to the Officer-In- Charge, Matigara Police Station in written and being directed, myself along with Const- 1035 Santosh Rabidas, Const- 1008 Kanak Roy and Const- 986 Rajib Sarkar all of Matigara PS, SPC along with investigation kit left for Biswas Colony More under Matigara PS by govt. vehicle to verify the veracity of the information. This refers to Matigara PS GDE No. 254 Dt- 06.04.2021 and M.C.C No- 669/21 Date- 06.04.2021.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Biswas Colony More I contacted two persons namely (i) Md. Irsad Alam S/O- Md. Javed Alam of Matigara Bazar, PO+PS- Matigara, Dist- Darjeeling and (ii) Sanjoy Mandal, S/O- Satyanarayan Mandal of Hare Krishna Pally, PO+PS- Matigara, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter we along with the independent witnesses noted above reached at Biswas Colony More under Matigara PS at 06:35 hrs and being pointed by my reliable source apprehended one person. Thereafter, we disclosed our identity and the information in hand and stated him that he will be searched in person for the purpose. At this, he after disclosing his identity as noted above admitted that he has illegally possessed brown sugar for selling the same to his designed customers as per their requirement. I then gave him option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer. At this he agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but, they did not search the police party. Accordingly, I informed the matter to O/C Matigara PS and as per his kind order, I informed to Shri Abunur Hossain, WBPS, Assistant Commissioner of Police, Head Quarters, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused person suspected to be possessed Brown Sugar and requested him to come at Biswas Colony More, under Matigara PS to remain present and to supervise the search and seizure.

Accordingly at 07:15 hrs Shri Abunur Hossain, WBPS, Assistant Commissioner of Police, Head Quarters, Siliguri Police Commissionerate arrived at the spot at Biswas Colony More as Special Executive Magistrate, SPC and in presence of two independent witnesses I searched the detained person following all formalities, keeping his decency and recovered the above noted article from the exclusive and conscious possession of the accused person namely Abdur Rasid (48) S/O - Lt. Khalilur Rahaman of Fatepur, PO. Maya, PS- Lalgola, Dist. Murshidabad (not verified). Further, on demand in presence of Shri Abunur Hossain, WBPS, Assistant Commissioner of Police, Head Quarters, Siliguri Police Commissionerate acting as Special Executive Magistrate, SPC, the detained person namely Abdur Rasid failed to produce any valid document in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packet with the weighing instrument and found 200 grams of brown sugar kept in a transparent pouch which was kept on the right side Pocket of trouser of accused Abdur Rasid and marked as "Exhibit- A". I also taken 20 grams of Brown Sugar from the packet as sample for examination and marked as "Exhibit A-1". Accordingly, I seized the above noted articles from the exclusive and conscious possession of accused namely Abdur Rasid at the spot at Biswas Colony More under proper seizure list in presence of independent witnesses and Shri Abunur Hossain, WBPS, Assistant Commissioner of Police, Head Quarters, Siliguri Police Commissionerate acting as Special Executive Magistrate, SPC obtaining their signature and being acknowledged by the accused person. Subsequently, I labeled and sealed all the articles in presence of Shri Abunur Hossain, WBPS, Assistant Commissioner of Police, Head Quarters, Siliguri Police Commissionerate acting as Special Executive Magistrate, SPC and independent witnesses and the accused person. The whole process of seizure was made in between 07.25 hrs to 07.55 hrs.

Being further asked the apprehend person namely Abdur Rasid admitted in presence of Shri Abunur Hossain, WBPS, Assistant Commissioner of Police, Head Quarters, Siliguri Police Commissionerate acting as Special Executive Magistrate, SPC and other independent witnesses that he has procured the brown sugar clandestinely from Kaliachak, Malda for the purpose of selling the same in high rate to his designed customer for his personal gain by illegal means. He also disclosed that he has been dealing in this business of procuring and selling of brown sugar illegally for last few months.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Abdur Rasid is involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Abdur Rasid after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Abdur Rasid (48) S/O - Lt. Khalilur Rahaman of Fatepur, PO. Maya, PS- Lalgola, Dist. Murshidabad (not verified) and arrange for its investigation.
