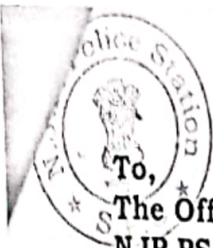

Sir,

With due respect, I am producing herewith the arrested accused person namely Bibhash Dutta @ Nantai (32 yrs) S/O Subhash Ch Dutta of Surya Sen Colony, Block A, Bhuttabari, PS- NJP, Dist.- Jalpaiguri under arrest and 01 "One Shooter" small Fire arm measuring 24 cm in length from butt to barrel with one trigger, striking hammer and striking pin in working condition loaded with 01 round live ammunition seized from the possession of the said accused. The ground of arrest duly been communicated with him.

I ASI Khagen Barman of NJP PS, SPC do hereby lodge this written complaint against the arrested accused Person namely Bibhash Drtta @ Nantai (32 yrs) S/O Subhash Ch Dutta of Surya Sen Colony, Block A, Bhuttabari, PS- NJP, Dist.- Jalpaiguri. In this regard I beg to report that today i.e. on 05.04.21 at 20.25 hrs I received a secret information that one person has been seen moving suspiciously at Hospital More, NJP and most probably for committing heinous crime and he possess one small Fire arm with ammunition. Diarised the information vide NJP PS GDE No 219 dated 05.04.2021 and informed the fact to my superior officers who directed me to work out the information in hand.

Following their directions myself along with C/1053 Paresh Rava VP/13 Jamirul Islam, VP/08 Laxman Roy, CV/306 Biswajit Roy all NJP PS, SPC left for NJP Hospital More area to work out the information in hand by Govt. vehicle. We reached at the spot at 20.45 hrs and as indicated by source we able to apprehend one person. We searched him immediately and found 01 "One Shooter" small Fire arm measuring 24 cm in length from butt to barrel with one trigger, striking hammer and striking pin in working condition loaded with 01 round live ammunition in his possession which he was carrying in his waist concealed underneath the shirt. On interrogation he disclosed his name and address as noted above. He admitted that earlier he was involved in several crimes under NJP PS. He exclusively possessed this improvised fire arm loaded with one live ammunition illegally. On demand he failed to produce any document in support the said improvised fire arm which is found in his possession.

Thus when his involvement in carrying and possessing illegal fire arm was established, I seized that improvised fire arms loaded with one live ammunition under proper seizure list duly signed by him as well as by available witnesses between 21.05 to 21.45 hrs and arrested him by preparing memo of arrest informing him the ground of arrest.

Under the above noted facts and seizure of incriminating articles there is strong reason to believe that the accused person namely Bibhash Dutta @ Nantai (32 yrs) S/O Subhash Ch Dutta of Surya Sen Colony, Block A, Bhuttabari, PS- NJP, Dist.- Jalpaiguri is desperate and dangerous in nature, as he was carrying the said fire arm loaded with live ammunition with an objective to commit heinous crime in the locality.

As he has willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the arrested accused person namely Bibhash Dutta @ Nantai (32 yrs) S/O Subhash Ch Dutta of Surya Sen Colony, Block A, Bhuttabari, PS- NJP, Dist.- Jalpaiguri under appropriate section of law.
