Sir,

In producing herewith the accused person namely Bappa Sarkar (27yrs),  
Kanu Sarkar of Fakdaibari Near Ram Krishna Sporting Club P. S. - Bhaktinager  
- Jalpaiguri with the seized fire arms & ammunition as noted below ----

One (1) Auto Pistol Made in USA, NO 10 having Marking K65 0101 of which  
length is 20 CM approx, Butt partial wooden measuring 9. CM, body measuring  
CM and barrel measuring 7.5 CM & Magazine measuring length 10 CM, breadth  
3 CM with one (01) live ammunition marked as KF 7.65 on percussion  
recovered from a bag filled with vegetables inside it from the possession of  
Bappa Sarkar.

I SI Pradip Kr. Singha of Ashighar OP beg to lodge this written complaint against  
above noted arrested accused persons to the effect that today on 04.04.  
22.35 hrs. received a reliable source information that one person named  
Sarkar kept conceal fire arm and ammunition at his Shop at Fakdaibari, Near  
Club which is supposed to be sold it to some other persons clandestinely  
diarized the fact in G.D. vide Ashighar OP. G.D.E. No -117 Dated - 04.04.2021  
directed by O/C Ashighar OP myself along with ASI Sumit Baran Nath, C/87  
Ahmed, and C/376 Shymal Choudhury all of Ashighar OP and taking a  
vehicle no. - WB42/R 8829 left for Fakdaibari Near Ram Krishna Sporting  
side to work out the information at 23.15 hrs which refers to Ashighar OP. (G.D.E.  
- 118 Dated - 04.04.2021. At 23.35 hrs on the way to Fakdaibari Near Ram  
Sporting Club and we disclosed our motto to (1) Sanat Das (30yrs.),  
Mongla Das of Niranjana nager W/no 36 PS Bhaktinager Dist Jalpaiguri  
Nityananda Saha (20 yrs), S/O Sri Ajit Saha of Hatath colony PS Bhaktinager  
Jalpaiguri. I requested them to accompany us to witness, Search and seizure  
made. They agreed and accompany us. Taking the witnesses we proceeded to  
Fakdaibari Near Ram Krishna Sporting Club. As indicated by my source we  
Fakdaibari Near Ram Krishna Sporting Club and kept watch from a little  
over there. At about 23.55 hrs we gradually proceeded nearer to his un-  
repairing shop but seeing us the said person tried to flee away from the  
somehow we managed to detain him. On search we found One (1) Auto Pistol  
in USA, NO 10 having Marking K65 0101 of which total length is 20 CM approx,  
partial wooden measuring 9. CM, body measuring 7.5 CM and barrel measuring  
CM & Magazine measuring length 10 CM, breadth 2.5 & 3 CM with one

ammunition marked as KF 7.65 on percussion cap recovered from a bag filled with vegetables inside it from the possession of accused Bappa Sarkar. On being demanded by me he failed to produce any valid document for possessing such fire arm and ammunition. Accordingly, I seized the same as alamt under proper memo of seizure duly authenticated by the witnesses and took him into custody. I also arrested the said person who disclosed his name and identity as noted above. The search, seizure and arrest were made in between 00.15 Hrs to 0045 Hrs. I also prepared label for the fire arm and one live cartridge.

Under the above noted circumstances, I pray, a specific case against the above noted accused persons may kindly be started under proper section of law and arrange for its investigation.
